Tips & Traps

How to avoid getting your Business Name Registration form rejected

If you are planning on registering a Business Name for the first time be sure to correctly fill in the BN Registration Form 1.

Here's our simple guide to getting it right.

- Never use abbreviations such as "Pty" "Ltd""Inc""Holdings" or "Group" at the end of your desired Business Name.
- Get the location and postal address right.
- If the business is located in a town, the section and allotment number must

be stated; if in a Building, the section and allotment numbers, name of the floor and building; if in a settlement, the area or town must be stated; and if at a village, the name of the village, area or district and the Province must be stated.

- The nature of your business must be clear. State no more than 2 related activities which are precise and related to the business name.
- Date or Proposed date of commencement of Business must be stated.
 Never use phrases such as "as soon as possible".
- An application may only be lodged within a 3-month period from 2 months before the proposed date of commencement and 1 month after the actual date of commencement of business.
- *If an application is lodged more than 2 months before the proposed commencement date it will be rejected.

High level European Investment Delegation visits PNG



PNG stakeholders hold round table talks with the delegation at Grand Papua Hotel in Port Moresby. The delegation was led by PNG's Ambassador to Brussels his Excellency Joshua Kalinoe.

Papua New Guinea can expect further cooperation with European countries following the visit of the first European Investment Delegation to the country from March 9-12.

In welcoming the delegation, particularly from Belgium and Netherlands, Chairman of the Independent Public Business Corporation (IPBC), Paul Nerau said this could be achieved by embracing the shared fundamental values of Rule of Law, Human Rights, and a free and independent media to foster Socio-Economic development to better both countries' welfares.

Mr Nerau on behalf of the PNG Government also told the visitors that PNG has social challenges which the Government has been addressing but despite that the safety of European workers was guaranteed.

"In this context, European countries can help Papua New Guinea address these social challenges, particularly through investment in infrastructure, education and training and agriculture, as an example," he added.

"I assure you that your investments will be

SME Corporation is now to replace SBDC

The new SME Corporation Act 2014 paves the way to succeed the Small Business Development Corporation (SBDC) following Parliament's passage, says Minister for Trade Commerce & Industry Richard Maru.

Minister Maru in a statement thanked the Government and Parliament for the overwhelming support he received when presenting the SME Bill of 2014 in Parliament.

Economic Growth and SME sector growth is a big policy priority for the O'Neill/Dion Government and the Minister is very thankful that the new legislation was passed, certified and gazetted into law.

The Minister said the corporate governance structure of the new SME Corporation will be the key difference between the SBDC Act and the new SME Corporation Act.

Under the new SME Corporation Act, the

Prime Minister is Chairman of the SME Council in which this was not the case under the SBDC Act.

"The critical Legislative reform is essential so the SME Sector gets the focus and the highest support from the Government because the SME sector growth is the key to support our economic growth and future as a nation," said Minister Maru.

He said the SME Sector can create over 60 percent of formal sector jobs instead of 20 percent today and contribute to 50 per cent of GDP instead of 10 per cent today.

He added a competent SME Board would be appointed and the subsequent appointment of a Managing Director be made by the NEC through the normal advertising process.

The Minister said: "This is especially critical I will be presenting the new SME Policy and SME Sector Master Plan 2015-2030 to the NEC and then later in Parliament in May sitting.

I will also be presenting critical enabling legislations including the Foreign Investment Regulation which also provides for reserved PNG businesses.

P&Os cruises' Pacific Dawn made its maiden calls to Madang and Wewak in February this year.

'Ready! Set! Tickets!!

The public can now purchase tickets to watch the various sporting events at the 4-18th July Games following the official 'go ahead' on 26 March, 2015.

The public is being encouraged to buy tickets by carefully following the Ticket Guide provided and correctly filling out a Ticket order Form from ticket outlets found at selected BSP branches nationwide.

What to look out for:

- Each event and location of the Pacific Games has a SESSION CODE number.
- You must find that SESSION CODE in the centre pages of the Guide and then write the SESSION CODE down on the Ticket Order Form.
- Every ticket you wish to purchase must have the SESSION CODE listed on the Ticket Order Form.
- The Ticket Order Form is a separate sheet of paper inserted loose inside the Guide.

The Games Organizing Committee officially launch the sale of 15th South Pacific Games Ticket.

- This Form is also available at every ticket outlet.
- This Form consists of four fields, the Ticket Order Form code, the quantity, the unit price and total price.

There are 3 types of packages for the Games; a Venue Package, a Sports Package and the Ultimate Package.

The Venue Package allows the buyer unlimited access to the venue from day one to the final day of activity whilst the Sports Package allows the buyer access to their chosen sport throughout its duration.

The Ultimate Package allows the buyer access to all venues and all sports with preferential seating. This package costs K5, 000 and includes the Opening and Closing ceremonies.




Laga to become biggest ice cream manufacturer in South Pacific

Construction to begin for World Class Tuna processing hub in Madang



The construction phase of the multi million kina Tuna Processing facility in Vidar, Madang is set to kick start this month in April.

The Pacific Marine Industrial Zone (PMIZ) Project valued at US\$95 million is an initiative of the Government of PNG to establish a world class facility that would take three years to complete and ready for business in 2019.

The project has been funded under a Chinese Export Import Bank concessional loan facility but was delayed for two years due to non completion of all technical pre-requisite studies required by the bank before the loan could be released.

The project engaged China Shenyang International Cooperation as the general contractor, which completed the Geotechnical Investigation study both for onshore and offshore port infrastructure in Vidar in February this year.

The Geotechnical Investigation study is the final technical pre-requisite study required by the Chinese Exim Bank.

The National Fisheries Authority engaged Rumbam Engineers Limited, a local engineering firm as project manager in overseeing the completion of all pre-requisite studies. Upon completion of these, the bank released the loan to commence Phase 1 (Detailing Engineering Design) and Phase 2 (Construction) of the project.

NFA project coordinator for PMIZ, Paul Martin has expressed satisfaction with the progress made and thanked Rumbam Engineers for its support in meeting the bank's requirements and getting the project back on track.

"Expansion plan for **Kurumul Tea & Coffee** plantations"

andowners of Kurumul Tea and Coffee in the Western Highlands Province are seeking a joint venture partnership to rehabilitate and manage the plantations.

The landowners have formed a company Bopin Investment Limited with its main objective of venturing into tea and coffee plantation development and management after the plantation was given back by the previous management, Warren Planation.

Located in the famous Waghi valley of the Anglimp South Waghi District, the site is an hour's drive from the provincial capital of Mt Hagen town.


The plantation has 100 hectares of coffee and 60 hectares of tea, which would be

ultimately replaced by coffee. This would increase the coffee plantation area to 160 hectares.

"Bopin Investment Ltd is looking at rehabilitating the plantation and importantly reviving the Parchment Dry Factory for green bean processing for exports," the company said.

The company needs a development partner to come in with management expertise and capital to revive the plantation in order to produce at maximum capacity.

UESTION

Question: Is it possible to merge two Business Names together"

Answer: No it is not possible. A Business Name allows you to carry out one particular type of business activity. The intention to merge two Business Names means that two different types of business activities will be carried out under one Business Name. Section 3 (Clause 2) of the Business Name Act states that "A separate certificate of Business Name registration must be obtained for each Business Name used.

On the other hand, a person or persons may conduct business under more than one business name, provided that the use of multiple business names is not calculated to seriously mislead the public about the business it conducts.

In particular, the business name is merely a trading name of a sole proprietor, a partnership or an incorporated body or firm.
