

Is it possible to merge two **Business Names together?**

This is not allowed by law. A Business Name allows you to carry out one particular type of business activity. The intention to merge two Business Names means that two different types of business activities will be carried out under one Business Name.

Section 3 (Clause 2) of the Business Name Act states that "A separate certificate of Business Name registration must be obtained for each Business Name used.

On the other hand, a person or persons may conduct business under more than one business name, provided that the use of multiple business names is not calculated to seriously mislead

the public about the business it conducts.

In particular, the business name is merely a trading name of a sole proprietor, a partnership or an incorporated body or firm.

It is therefore advisable that you register a separate Business Name for a separate business activity.

Note that you cannot change a business name as well as per the Business Name Act.



The Investment Promotion Authority (IPA) has launched a Help Desk in Kimbe, West New Britain Province that will help the people in the province in terms of business registration and the provision of information on other IPA functions including intellectual property, investment promotion, facilitation and aftercare services.

The launch of the IPA Help Desk follows the signing of a Memorandum of Understanding between the West New Britain Provincial administration and the Investment Promotion Authority back in 2018.

Managing Director of the Investment Promotion Authority, Clarence Hoot when officiating during the launch highlighted that the launching of the IPA/WNBPA Help Desk will bring services closer to the people and assist local SMEs in terms of business registration and the provision of basic compliance advice. The Help Desk is established within the West New Britain Provincial Government's Commerce Office.

Mr Hoot said the launch also signifies IPA's efforts to develop a strategic partnership aimed towards meaningfully delivering IPA services to our people. He said this strategic partnership with IPA will empower the people of West New Britain Province through

the registration of their business activities and provide investment opportunities for the province. He thanked the Governor for West New Britain Province, Honourable Sasindra Muthuvel and the Provincial Administrator Mr Williamson Hosea for their ongoing support and cooperation rendered since 2018.

He further mentioned that the IPA will be ready to provide training for the Commerce Officers to ensure provision of efficient services to clients in West New Britain. Governor for West New Britain Province, Sasindra Muthuvel thanked IPA for recognising the need to have IPA services in the province and urged his people and especially block holders to startup businesses with the money they earn from oil palm. He said people travelling long distances just to access IPA services will now be a thing of the past.

Similar sentiments were shared by the Provincial Administrator, Williamson Hosea. At the time of the launch, the province also had several visits by a number of national agencies including Small & Medium Enterprice Corporation (SMEC) and Centre for Excellence in Financial Inclusion (CEFI), running small business skills and financial literacy skills, hence IPA's presence in the province also complemented their efforts.

IPA supported the set-up of the Help-Desk for West New Britain Province with a computer/desktop and an all-in one scanner and a printer.

This is the standard assistance IPA gives to all the Provinces that it signs an MOU with. Other related costs are to be borne by the provincial administrations, in this case the West New Britain Provincial Administration.





A group of women Leaders from East New Britain Province visited the Investment Promotion Authority's Head office in Port Moresby in September meeting to have an awareness with IPA.

The women's group comprised of both Government and private sector members who are keen to increase the number of women in the formal business space and wanted to know how IPA can assist them.

The meeting was organized by the Registrar of the Intellectual Property Office, Ms Amelia Na'aru after a request was put forward to IPA by the women leaders.

The IPA team who met with the women leaders included the Director of Corporate Services, Ms Anna Marikawa, Acting Registrar of Companies Ms Harriet Kokiva amongst others.

The women leaders travelled to Port Moresby from East New Britain with the aim of collecting first-hand information on the different mandated roles and responsibilities of IPA.

Discussions held during the meeting included the importance of registering a business, the difference between a Company and a Business Name and the difference between an Association and Cooperative Society.

The team also explained to the women leaders the difference between filing an

Annual Return at the IPA and the payment of Tax Returns at the Internal Revenue Commission. Social Entrepreneur and Owner of DMS Limited, Dorothy Luana who was among the women leaders expressed concern on the lack of information that SMEs get regarding the IPA services.

"We want SMEs to be educated on the importance of registering a business and the different compliance issues and not ONLY on taxation. We want to understand how and where we can work with both IPA and IRC".

A presentation was also made on the importance of protecting each of the four (4) Intellectual Property rights which include Trademarks, Copy rights, Patents and Industrial Designs, and how these rights apply to business.

At the end of the meeting, the women leaders expressed gratitude for the opportunity to meet with IPA and to be educated about IPA functions.

IPA conducts awareness on IP and Technology at POMIS

tudents of the Port Moresby Intern tional School (POMIS) who attended a presentation by IPA's Intellectual Property Office during their school's Technology Day on the 10th of September, 2021 were encouraged to be innovative and creative at a younger age when it comes to the creation of new works involving technology.

The students also had the opportunity to be given first-hand information on the importance of doing business and how it relates to technology in terms of Intellectual Property protection.



The Intellectual Property Office was in-

vited by the Port Moresby International School to participate in its Technology Day with the Theme: "Learn, Adapt and Move with Technology". The Technology Day is an annual event which is organized and hosted by the School's Technology Department. The aim of the event was to impart new knowledge to the students about the importance of technology in the twenty-first century.

Speakers were invited to talk and motivate students should they want to pursue work in the field of technology in the future.

Officers from the Intellectual Property office who did presentations on that day on Intellectual Property and technology spoke on the importance of the use of Intellectual Property (IP) and how technology creations are protected by IP Rights. They also outlined IPO's main roles and responsibilities and how each of the IP rights relates to technology including Trademarks, Industrial Designs, Patents and Copyrights.

A booth was also set up in the school's display room where students who visit



ed the booth were given explanations on the roles and responsibilities of IPO, and the four IP rights that the IPO office administers. There were also displays of student creations and works such as furniture includingtables, shoe racks, cabins, stools, coffee tables, plastic photo holders/ frames, photographs, sown materials including meri blouses, cooking aprons and designed laplaps.

The students also displayed works involving the designs of mini-computer laboratories and internet cafeterias and were tasked to explain their innovations.

The day ended on a high note with the teaching staff of the technology department of POMIS expressing appreciation for IPA's participation in the event.

IPA to set up Help Desk in Namatanai District of New Ireland Province

The people of Namatanai District in New Ireland Province will soon have access to adequate IPA services.

This follows a brief visit to the District by the Managing Director of the Investment Promotion Authority, Mr Clarence Hoot to re-affirm a commitment which was made by the IPA Board Chairman, Mr Leon Buskens to set up the Help Desk.

Mr Buskens, who presided at the inauguration of a Bank South Pacific branch in Namatanai, had publicly announced that IPA would set up a Help Desk in Namatanai to assist the people of Namatanai District in terms of having

access to IPA services.

The commitment was made in light of the struggles that the people of Namatanai are currently enduring in terms of having access to services by IPA, specifically in terms of business registrations.

There is also an increase in business and investment activities in the district.

MD Hoot said the need to establish anIPA Help Desk in Namatanai District was initially noted during IPA's last visits to New Ireland Province including the signing of an MOU with the New Ireland Provincial Administration in June 2018 and the set-up of an IPA Help Desk in Kavieng in October 2019.

The office space for the IPA Help Desk has been allocated within the Namatanai District District Administion and Urban LLG office.

Training and the equipment will be provided for the responsible Commerce Officer to administer the IPA Help Desk within the Namatanai Urban LLG Office.



cally independent. Owner of Helping Hand Honey Producer (HHHP), Kelly Inae initiated HHHP to help farmers in the rural areas in Eastern Highlands Province venture into the

honey business.

HHHP provides training to farmers who are interested to start honey bee farming for the first time and farmers who are already into honey farming but need advance training. Mr Inae

said farmers need to know how to work with thousands of stinging bees, identify

for bee box making. Farmers are taught to build their own bee boxes by using basic carpentry tools and materials. They are also taught to do bee box maintenance as well in the event that the bee boxes get old and rot-

Among other trainings, farmers are taught special skills for breeding queen bees. HHHP has a queen breeding station to produce quality queen bees. The queen bee is very important in maintaining the bee colony.

HHHP came up with the idea of "Mountain Honey", a honey making business to help farmers in rural areas by training them as beekeepers. Yet, despite the owner, Mr Inae's best intentions, he soon realized it wasn't pos also good for generating house-hold income. Honey is more expensive compared to other commodities and bee keepers are expected to generate more money. The price for honey is much higher than for other commodities."

"Mountain Honey's philosophy is based around providing beekeeping training to both the wife and husband in each family. "We call it a family unit project," Kelly says.

Mountain Honey has its small production facility at Gonah in the outskirts of Goroka Town located at a fresh natural habitat conservation environment. The Mountain Honey has its honey farm at Gonaha Natural Habitat (www.gonaha. com).

Mountain Honey is the sustainable business that source honey from its 3 hector farm and get honey supplies from other honey farmers and process it for domestic markets.

Mountain is the product name produced by Helping Hand Honey Producers. Helping Hand Honey Producers is the second largest honey producer in Papua New Guinea that produces Mountain Honey and it is second to Highlands's Honey (products of Niugini Fruit Company).



The business (Helping Hand Honey-Producers) was formally registered with the Investment Promotion Authority in 2013 and is owned by Mr. Kelly Inae. Mr. Inae is an experience honey bee famer, honey producer and honey keeping trainer who started honey business in 2002 and has been in the honey industry for more than 17 years.

Mountain Honey has a vision for growth and sustainable honey the industry and thus his business has taken a proactive approach by conducting honey keeping trainings across the highlands provinces as well other regions.

With the visions and dreams of sustainable industry growth, Mr Inae is the only honey farming trainer that has conducted trainings in the highlands provinces which he has helped trained more 2500 people in rural areas to become honey bee keepers. He has been training the farmers since its inception in 2002 and continues to support honey famers.

He is currently conducting trainings both at Mountain Honey's Training Facility at the farm, its production site and in various provinces.

Helping Hand Honey Producers buys honey from the farmers who have been trained by Mr. Inae and produce Mountain Honey at its mini honey processing plant. His products are packaged or bottled inhouse in his own bottling and packaging facilities.

Mountain Honey is seen as a sustainable business and the products are sold domestically in supermarkets in Papua New Guinea. The products are also packed in different volumes and grams and sold to individuals and businesses around the country.



Some of his products are also transported from Goroka via road transport to customers in other highlands provinces as well as Madang and Lae.

For outside centers, products are airlifted out from Goroka Airport and Ukarumpa Air Strip in Aiyura to other coastal centers and Port Moresby.

The product is 100% pure organic without the inclusion of artificial additives and its demand is growing rapidly among Papua New Guineans.

SIGNS THAT CANNOT BE USED AS TRADEMARKS



What about signs that can't be used as trademarks?

Signs with the following characteristics cannot be protected as trademark:

- Those that mislead the consumer in relation to the geographical origin;
- Those that mislead the consumer in relation to the quality or nature of the product or sevice which the trademark relates;
- Those that are contrary to moral or public order;
- Those that consist of, or contain reproductions of armorial bearings, flags, and other emblems of States party to the Paris Convention or the World Trade Organization (WTO);
- Those that are official signs and hallmarks indicating control and warran ty adopted by them, and any imitation from a heraldic point of view.



In conclusion, there is a wide variety of signs that can be used as trademarks, but in order to be protected as trademarks, the signs must be distinctive, not deceptive and comply with the other protection requirements established by the law of the country where protection is sought.

Investment Promotion Act Review Update

The amendments to the Investment Promotion Act once passed by Parliament is expected to give effect to a number of key changes to how we do business in the country and will greatly support the growth of Micro Small Medium Enterprises in the country.

The process for determining reserved and restricted activities will be clearer and more consultative.

Among these changes is the introduction of a new foreign certification system which will process applications for foreign certificates quicker, and automatically deny applications for reserved activities.

A new position for a Registrar of Foreign Investment will also be created to oversee this foreign certification system with powers to speed up wanted incoming investment, automatically deny unwanted investment and enforce compliance.

The amendment will also require foreign investors wanting to live and work in PNG to demonstrate financial investment capacity threshold of actual investment before

they are granted a business visa.

The minimum investment threshold to live and work in PNG is aimed at deterring non-genuine foreign investors entering into lower-capital activities in direct competition with PNG citizen owned Micro Small Medium Enterprises.

The reserved Activities List will also be reviewed at least every 3 years.

This will further improve IPA's enforcement and compliance, and making better allowances for cross-agency enforcement. There will be an introduction of clearer reporting obligations by foreign investors, and IPA through the Registrar of Foreign Investment will be empowered-with powers to cancel certification where key PNG business laws are breached.

There will be time allowed for grandfathering of existing foreign owned businesses currently conducting activities in the new Reserved Activities List.

Removal of a Local Company from the Registry

I am the owner of a locally registered company but no longer want my company to operate, therefore want to have it removed from the IPA registry. How do I go about doing that?

ANSWER:

Under the Companies Act you are required by law to complete and lodge Form 45 'Request to **Remove Company from Register'**. The form gives guidance as to who can be authorized to make the application – be it a shareholder, director or a person permitted by the constitution.

Form 45 should be accompanied by two important supporting documents, unless the Registrar agrees otherwise;-

- a.) Written notice from the Commissioner General of IRC stating that the Commissioner has no objection to the company being removed from the register and;
- b.) A copy of the special resolution of shareholders.

Don't forget that copies of Notice of Removal publicized in one of the daily papers and the National Gazette respectively which normally provides a one month objection period should be attached together with the above mentioned.

It is also important to note that any outstanding annual returns must be filed before the company is removed from the register.

The fee for lodging Form 45 is K50 if done online and K100 at the counters.
